- 1. <u>Purpose</u>. To announce the Office of Management and Budget (OMB) clearance of a revised ETA 653, the Job Corps Health Questionnaire, and to provide the Job Corps community with updated versions of the ETA 653 Instructions and the ETA 653 Documentation Guidance.
- 2. <u>Background</u>. OMB requires a periodic review of reporting forms. The revised ETA 653, ETA 653 Instructions, and ETA 653 Documentation Guidance are attached to this directive. Admissions Counselors can access the ETA 653 through the Outreach and Admissions Student Input System (OASIS) while performing admissions interviews.
- 3. <u>Explanation of Changes</u>. Changes in the revised ETA 653, ETA 653 Instructions, and ETA 653 Documentation Guidance are as follows:

a. ETA 653 (Attachment A)

- 1) Updated the Purpose Section.
 - Added "... to obtain and verify consent for required routine medical assessments and/or consent to receive basic health care services ..."
- 2) Expanded, added, and removed questions.
 - Question #2 changed "Student" to "Applicant"
 - Question #7a added "... other than Medicaid"
 - Question #8c added "... CPAP, hearing aid ..."
 - Question #8 added new question 8h. "Had a medical or surgical procedure?" Re-lettered subsequent questions throughout this section.

- Question #8 substituted old question 8t, "Been expelled from school, fired from a job, or convicted of a crime?" with "Been in a physical fight that resulted in hospitalization or significant injury of you or the other person?" Re-lettered subsequent questions throughout remainder of this section.
- Question #8u removed "... (e.g., charges of disorderly conduct, assault, etc.)"
- Question #8w added "... alcohol or drug abuse ..."

3) Updated and added new conditions (Question 9).

- Condition #91 added "... or colitis"
- Condition #90 added "Cancer/malignancy"
- Condition #9p added "Sleep apnea"
- Condition #9q added "Organ transplant"
- Condition #9r added "Muscle or bone disorder"
- Condition #9ee replaced "Pervasive Developmental Disorders" with "Autism Spectrum Disorders"
- Re-lettered conditions throughout

4) Consent Section.

• Third bullet – added "... sexually transmitted infections ..."

b. ETA 653 Instructions (Attachment B)

Instructions were updated to match changes made to revised ETA 653.

c. ETA 653 Documentation Guidance (Attachment C)

Documentation Guidance was updated to match changes made to revised ETA 653.
